The Highland Park Parade Shooting

Highland Park, Illinois, was a peaceful, suburban town that approximately 30,000 people call home, nestled on Lake Michigan, about 25 miles north of Chicago. A perfect and beautiful July 4, 2022, friends and neighbors streamed into the downtown for the annual parade – the first since the COVID outbreak. More than 3,000 parade goers lined the route, decked out in a sea of red white and blue – and the bicycle and pet parade kicked off the festivities at 10:00 a.m.

At 10:14 a.m. a lone gunman, armed with a Smith & Wesson M&P 15 semi-automatic rifle fired more than 83 rounds in less than 90 seconds.

The rapidfire staccato of the gunshots shocked the attendees and shattered the community, leaving seven murdered and dozens hurt and injured.

Many will bear physical scars and severe trauma-induced mental health challenges for the rest of their lives. In the days following the mass shooting, nearly 1,200 people sought trauma counseling at the resource center established at the local high school.

Highland Park had the uniquely American experience of a 4th of July parade turn into what has now become the uniquely American experience of a mass shooting.

The impact of one man with an assault weapon and three 30-round magazines has been immeasurable, and the community responded in kind.

The shooting prompted an outpouring of support from the local community and across the globe.

The Highland Park Community Foundation (HPCF), in cooperation and with the support of the City of Highland Park, created the July 4th Highland Park Shooting Response Fund (the Fund) to provide a charitable vehicle to assist victims of the tragic event, support nonprofit organizations serving the needs of impacted residents of Highland Park, Highwood, and other local communities, and to assist the Cities of Highland Park and Highwood in supporting the community by lessening the burdens placed directly on governmental services through the financial resources to be received and distributed by the HPCF and the Fund.

Highland Park Mayor Nancy Rotering and the City of Highland Park publicly designated the Highland Park Community Foundation and the Fund as the City's vehicle for donations. "The Highland Park Community Foundation has proven itself to be a trusted local resource which has been a valued partner and effective administrator of grant-making funds," said Rotering. "We know they will distribute the funds in a fair, transparent, and straightforward process that will focus on the needs of victims, their families, and our community."

Following the shooting, the HPCF established a donation page on its website. The HPCF also pledged to distribute 100% of gifts to the victims, their families, and nonprofit organizations serving the needs of the victims and the community.

On July 27, 2022, the HPCF announced it had formed a committee – Together Highland Park Unidos (the Committee) – to manage the donation distribution process. The Committee, made up of diverse and local community leaders, committed to an open, transparent, and expedient process to help victims and the community as a whole.

The Fund distributed \$5,225,102 to victims who suffered physical injuries and to the families of those killed. An additional \$580,025 was distributed to community organizations to address the mental trauma experienced by individuals in the community.

Goals

The Committee's primary goals for administering the Fund included:

- Providing financial support to the victims of the July 4th shooting, their families, and the organizations that were helping them as soon as possible.
- Providing transparency around the process for all stakeholders.
- Keeping the needs of victims and their families at the center of all processes.

The Committee members named Betsy Brint Chair of the Committee and Terri Olian managed the administrative work associated with the Fund, shouldering a considerable amount of the collective work.

Timeline

The Committee's first meeting took place on July 10, 2022. Its meetings throughout July focused on integrating the expert input being received with the values of our community and the goals for the Fund that the Committee had established.

On July 27, 2022, the Committee published a Draft Protocol, its proposed methodology to evaluate and allocate funds for all claims. This Draft protocol contemplated the appointment by the Committee of Administrators to evaluate and process claims, and addressed other procedural matters.

The Committee scheduled meetings, in English and Spanish, with victims' families to review the Draft Protocol and consider their input, and allowed the public an opportunity to similarly comment. These meetings were held on August 10, 2022, at the Highwood Public Library and Community Center at 2:00 p.m. in English and 7:00 p.m. in Spanish and on August 11, 2022, at the Highland Park Public Library at 2:00 p.m. in Spanish and 7:00 p.m. in English.

The Committee also agreed to develop a dedicated website to provide information, distribute claim forms, and collect donations, and it became available to the victims and community at large on August 11, 2022, at july4fund.org.

The Committee published its Final Protocol on August 17, 2022, incorporating feedback from victims, their families, and the community. At that time, the Fund Administrators were announced, and the claims process was opened. Claim forms were published in English and Spanish.

Individual claim forms were due September 7, 2022. Prior to and following this date, the Administrators met with victims and their families, and various community organizations assisted victims and their families in completing the forms.

The Committee received the distribution recommendations from the Fund Administrators on October 22, 2022, and approved their distribution proposal.

On October 23, 2022, the Administrators notified all claimants whose claims were ineligible. Notification letters were sent by email and through the U.S. mail in English and Spanish.

On October 31, 2022, the Administrators notified, in English and Spanish, each eligible claimant of the amount they were awarded. Checks were sent via registered mail or made available for pickup at the Highland Park City Hall Finance Department. On November 1, 2022, after notifying all claimants, the Committee issued a press release with information about the Fund total and its distribution.

Meetings

The Committee and its advisors met 20 times between July 2022 and the end of October 2022. During that time, the Committee gained considerable understanding of the legal, ethical, and practical intricacies of distributing funds collected in response to a tragedy.

Factors Informing Committee Work

The Committee worked methodically and thoughtfully, following legal doctrine, reviewing the work of others, learning from expert sources, and, above all, listening to victims and their families.

Reviewing the Work of Others

While there is no single way to distribute donations collected after such a tragedy, there is an unfortunate reality that many, many others have experienced similar trauma. The Committee sought out the work of others who had tackled such difficult work – including the Waukesha parade attack, the Tree of Life synagogue shooting in Pittsburgh, the One Orlando Fund for the Pulse Nightclub shooting, the Boston Marathon bombing, and the 9/11 Fund.

The thoughtful work of these groups who had tackled many of the same challenges helped inform the Committee's work – and while all encountered very different circumstances, each shared a common mission to keep victims and their families at the center of each decision.

This dominant theme guided each and every action and formed the basis for all the Committee's decision making.

The Committee is deeply grateful to the volunteers from these organizations who shared their time, experiences, and empathy with our Committee.

Learning from Expert Sources

The Committee also sought the advice and counsel of experts in the field including Kenneth Feinberg, the Special Master of the U.S. government's September 11th Victim Compensation Fund and the Administrator of the One Fund established in the wake of the 2013 Boston Marathon bombings. The Committee spoke with Feinberg and his partner Camile Biros on July 11, 2022, and Committee members and Administrators spoke with them several times thereafter to discuss multiple issues and logistics regarding Fund's allocations and distribution.

The Committee Chair also met with Jeff Dion, Executive Director of the National Compassion Fund, and met several times with Anita Bush, President and Zachary Blair, Vice President of VictimsFirst. Other outreach included conversations with Jeff Finkelstein, President and CEO, Jewish Federation of Greater Pittsburgh, and Stephen Cohen, Co-President, New Light Synagogue in Pittsburgh.

These individuals generously shared their insights, thoughts, advice, and counsel, all of which the Committee incorporated into its recommendations, processes, and protocols.

The experts' advice helped inform some of the Committee's most difficult questions and decisions. Knowing the needs for mental health services would be vast, they helped the Committee determine how best to serve these needs. Their advice also reaffirmed the Committee's understanding that no amount of money would compensate for loss of life, serious wounds, or trauma. Rather, the funds would be distributed as gifts of compassion.

Feinberg advocated for a model where the Committee would determine a protocol for distribution, but an independent Fund Administrator would evaluate the claims being made and allocate the distributions. He shared caution about the difficult work of that role and encouraged the Committee to seek an individual or individuals who would work to make decisions in the best interest of the victims and donors, and who would effectively and efficiently make determinations, while adhering to the protocol.

Essential Legal Advice: Latham & Watkins Legal Team

An essential component of the Committee's work was the *pro bono* legal counsel provided by Latham & Watkins. Mark Gerstein, a senior partner at the firm, an adjunct law professor at Northwestern University, and a longtime Highland Park resident, and widely considered an expert in negotiation, quickly assembled a team of professionals who donated time and talent to assist. They also endeavored to assure the Committee acted in a fair, legal, and expedient manner.

In addition to Mark Gerstein, the Latham team included partners Diana Doyle and Dan Breslin; associates Karen Klass, Gharrett Favinger, and Daniel Robinson, Stephen Lessard, *pro bono* Managing Attorney-Tax Exempt Organizations, and summer intern Shelby Dedo.

In just 10 days, the team worked with the Committee to establish the Committee's organizational structure, including a governing body with plan administrators, a Draft Protocol for claims, and a comment process for victims, families,

and the public. The firm and its vendors also underwrote the cost of professional translation to ensure materials were simultaneously presented to the victims and public in English and Spanish. The work of the Committee took place at all hours of the day and night – as all recognized the importance of moving forward quickly, in the interest of distributing funds to the victims. The Latham team worked around the clock to ensure the Committee had all the resources it needed to accomplish its goals and objectives.

Listening to Victims and their Families

The Committee understood from the beginning that its primary responsibility was to support the victims and impacted members of the community.

The Committee scheduled four meetings with victims and their families to share information, receive input, and to listen to the needs of those who suffered most. The Administrators were present for these meetings as well.

Upon publishing the Draft Protocol on July 27, 2022, the Committee invited victims and their families to offer feedback at four meetings:

- August 10, 2022, at the Highwood Public Library and Community Center (102 Highwood Ave., Highwood) 2:00 p.m. in English and 7:00 p.m. in Spanish
- August 11, 2022, at the Highland Park Public Library (494 Laurel Ave., Highland Park) 2:00 p.m. in Spanish and 7:00 p.m. in English

The purpose of the meetings was to better understand the victims' injuries and losses, the physical and emotional trauma, and in many cases the persisting or permanent consequences of being present at, and a victim of the events of, the parade. Those conversations deeply informed the Committee's approach to how to best use the funds donated for those affected by the shooting.

Out of respect for those who had lost family members as a result of the shooting and victims who were physically injured, these meetings were not open to the public or press.

Presentation

The same presentation was made at all four meetings, in both English and Spanish. A copy of the presentation can be found in Appendix E of this report.

Wanting to hear from the community as well, the public was invited to submit written comments about the Draft Protocol. Those comments were collected through August 11, 2022.

Commitment to Bilingual Communication

At its formation, the Committee recognized that the tragedy impacted many members of the community for whom Spanish is their primary language. The Committee therefore included fluent Spanish speakers and committed to publishing materials, including protocols, claim forms, instructions, and frequently asked questions in both English and Spanish. The Committee also provided bilingual assistance throughout the claims process.

Addressing the Mental Trauma of the Parade Shooting

Immediately following the shooting, the Committee recognized the important role that many agencies would play in addressing the mental health, legal, and other needs of victims and community members who were impacted by the shooting, but not necessarily physically injured.

Significant dialogue took place between members of our community, the Committee, and the Administrators about how to address the mental health needs associated with the mass trauma experienced by the thousands who attended the Parade. The Committee and Administrators also met separately and considered this issue at length. After consulting with other experts and communities that had experienced similar tragedies, and after consideration and evaluation of the resources nonprofit organizations in our community could make available to those so affected, the Committee determined that rather than making what would

likely be nominal allocations of donated funds to each of the individuals emotionally affected by the tragedy, the most effective way to address their needs was to fund community organizations that could broadly and cost-effectively support them.

Respecting Donor Intent

The Committee recognized that no amount of money can compensate for loss of life or injury from such a senseless and horrific event. The donations came as gifts of compassion, and the Committee sought to maximize the impact of the donors' gifts to serve and comfort those who were injured.

Gifts for the July 4th Highland Park Shooting Response Fund were unrestricted, but the Committee understood that the intent of the donors was for their donations to aid victims. The Committee therefore distributed 100% of the donations to families of victims who were killed at the Parade, victims who were physically injured, and nonprofit organizations serving them and the community.

Appointment of Fund Administrators

The Committee understood that appointing a thoughtful Fund Administrator was a critical decision. The Committee needed to select an individual(s) with a high degree of integrity, empathy, and a sincere connection to the community. Members of the Committee considered eight individuals for the role of Administrator, and remain deeply appreciative of all who volunteered for this challenging role.

The Committee Chair interviewed four and then presented the candidates to the Committee.

The Committee selected Bruce Boyd and Eric Kessler to serve as Co-Administrators. Boyd, a long-time resident of Highland Park and Spanish-speaker, and Kessler, a Highland Park native, both have extensive experience with grant management. They also serve as principals at Arabella Advisors, one of the country's leading philanthropy consulting firms, providing strategy and operations support to America's largest and most impactful philanthropists.

The Administrators recognized the importance of their position and worked together to execute the Final Protocol, following the distribution model developed by the Committee. Their process included meeting with victims, reviewing all claims, and submitting payment determinations to the Committee.

A report from the Administrators is included as Appendix A in this report.

Final Protocol Published

On August 18, 2022, Together Highland Park Unidos released the Final Protocol, which guided the distribution of the Fund, made claim forms available to victims, and officially named the Fund Administrators.

The Committee made all relevant documents available for claimants, families, and all interested parties on the Fund website, July4Fund.org, by phone request, and at the Highland Park Public Library, Highwood Public Library and Community Center, Family Service of Lake County, and North Suburban Legal Aid Clinic.

The Committee conducted extensive outreach to nonprofit organizations in the community, emailed all individuals who attended the forums, and contacted the Lake County State's Attorney's office to reach as many potential claimants as possible. While privacy laws prevented the Committee from receiving contact information from government agencies, the Committee identified victims named in the public indictment, reaching more than 95% by email.

The Committee issued multiple press releases and sent emails notifying the community and media outlets that it had published the Final Protocol and claim forms were available. The Final Protocol and claim forms were published in both English and Spanish.

Claim Forms Distributed

One of the Committee's primary goals was to make the claims process as straightforward as possible. Feinberg and other experts emphasized that it may be difficult for claimants to secure documentation and urged the Committee to be mindful of these challenges. Burdening victims and families with extensive paperwork and requiring documentation that could pose privacy risks served little purpose and could delay the processing of claims.

Following this advice, the claim form did not require extensive documentation or medical information. Rather, it only required a letter from a medical provider certifying that the claimant had received treatment for a physical injury as a result of the July 4th Highland Park shooting, and, if applicable, was hospitalized for a specified number of nights.

Highland Park Hospital treated many of the victims injured in the shooting and served as a central resource in helping victims obtain appropriate documentation. They provided a dedicated phone number for victims to reach the registration department, assisted with the distribution of letters, and conducted outreach to peer institutions in the area to ensure other hospitals made it as easy as possible for victims to obtain the documentation needed to support their claims. We are grateful to the NorthShore University HealthSystem and Northwestern Medicine for the invaluable

assistance and support they provided to the Administrators' efforts in this process.

Once the Final Protocol was published and claim forms were made available, the Committee began assisting victims with the documentation and filing process.

Highwood Public Library and Community Center

The Highwood Public Library and Community Center (Library) provided many vital services to both the Committee and community during this time. In addition to hosting public meetings, the Library provided a staff member to respond to messages left on the Fund's dedicated phone number and email account in both Spanish and English.

The Library also served as a central resource for individuals filing claims. Members of their staff worked with Committee members to develop procedures for accepting and securing applications and to ensure claims were handled confidentially. They followed up with victims when documentation was missing or files were incomplete and served as an important link between the community and the Committee.

The Library staff provided help daily between August and September and hosted sessions to assist those completing claim forms on Tuesday, August 30 and Saturday, September 3. During these sessions, bilingual committee members and staff from the North Shore Legal Aid Clinic were available to help victims complete paperwork and answer questions about eligibility.

The Committee is deeply grateful for the role the Library played as a trusted resource for the community, and greatly appreciates the vital resources they provided to the Foundation during this process.

Gifts received after October 7, 2022

The July 4th Highland Park Shooting Response Fund closed on October 7, 2022, in order to determine final amounts for distribution to victims and nonprofit organizations.

Simultaneous with its closure, the Highland Park Community Foundation opened a second fund to accept donations that would be used to address continuing needs of victims and community members for mental health and other services resulting from the shooting. Donations to the second fund will be distributed to nonprofit organizations supporting their needs. The Highland Park Community Foundation will administer the second Fund and distribute the donations through a grant process.

Methodology and Fund Distribution

The funds were distributed according to the Committee's Final Protocol. Eligible individual claims were grouped into three categories:

A. Death Claims and Permanent Catastrophic Physical Injury Claims

Deceased victims and those who suffered permanent catastrophic physical injuries such as severe brain damage, amputation of limbs, or severe paralysis as a result of the shooting. Eligible claimants in this category all received the same payment.

B. Physical Injury Claims for Victims Requiring Overnight Hospitalization

Eligible claimants who were physically injured and initially hospitalized within 10 days of the shooting (July 4–14, 2022) for one or more nights due to physical injuries as a result of the shooting received payment under category. Individual distributions were based on the number of overnight stays in the hospital.

C. Physical Injury Claims for Victims Treated at Hospitals, Medical Facilities, or by a Medical Professional Solely on an Out-Patient Basis

Eligible claimants physically injured as a result of the shooting, treated by a medical professional, and released without an in-patient hospital stay. Eligible claimants in this category all received the same payment.

A fourth category of claims, for nonprofit organizations serving the needs of victims was managed through another process, detailed below and in Appendix B of this report.

Submitted Claims

The Fund received a total of 78 claims by the deadline of September 7, 2022. No claims were filed after the deadline.

Once the deadline passed, the claims were turned over to the Fund Administrators for review and evaluation (see Appendix A).

The Administrators committed to speaking with every claimant who requested a meeting to allow claimants to explain extenuating circumstances that would help the Administrators determine the appropriate category for their claim.

Several claims were incomplete and did not have adequate documentation. In these circumstances, the Fund Administrators and Committee members worked with claimants to secure the necessary documentation, such as an appropriate medical letter or legal documentation in the case of parents of minor children.

A total of 11 claimants could not secure a letter from a medical professional documenting that their injuries were a direct result of the parade shooting. These claims were declared ineligible. One claimant later withdrew their claim.

The final number of eligible claims was 66. The total amount distributed to individual claimants was \$5,225,102.

Category D: Grants to Nonprofit Organizations

The Committee recognized the important role that many agencies would play in addressing the mental health, legal, and other needs of victims and community members who were impacted by the shooting, but not necessarily physically injured. Knowing the financial strain this would put upon these organizations, the Committee determined these agencies should constitute a category of Fund beneficiaries.

The Committee decided the organizations would be eligible for funding for services they delivered that extended beyond those that were part of their normal day-to-day operations. The Committee also determined that funding would be based on the increase in and type of client services provided as a result of the shooting and would only be provided for expenses that were not reimbursable by any state or federal government.

Appendix A: Administrators' Report

Bruce Boyd and Eric Kessler

When Besty Brint, the Chair of the Highland Park Community Foundation, called to ask if we would serve as the Administrators of the Highland Park Victims Fund (the "Fund"), we were honored to do so. Like everyone with a connection to Highland Park, we were deeply affected by the July 4th shooting. Bruce has lived in Highland Park since 1994 and raised his two children here. Eric was born in Highland Park and went to Highland Park schools, graduating from Highland Park High School. We had numerous friends who were at the parade and acquaintances who were injured. As Betsy knew when she called, we were well positioned to take on this important but challenging task. Over the last 16 years, the two of us have co-lead the leading philanthropy consulting firm in the country. In that role, we have managed large grant making programs and have worked on a range of important issues, including efforts to reduce gun violence. In addition, Bruce speaks Spanish, and we knew many of the victims were originally from Latin America.

The first thing we did when we agreed to serve as Administrators was to speak with others who had played this role in connection with other shootings and disasters, and review documents that other Funds and Administrators had created. This gave us a solid grounding in what others had done and learned. We also engaged with Together Highland Park Unidos, the July 4th Highland Park Shooting Response Fund Committee (the "Committee"),

which was developing the protocol that would guide our work in distributing the donated funds. The Committee published its Final Protocol on August 18, 2022. Claims were due on September 7, 2022. The Committee established four categories for claims:

- Category A – Death Claims and Permanent Catastrophic Physical Injury Claims
- Category B – Physical Injury Claims for Victims Requiring Overnight Hospitalization
- Category C – Physical Injury Claims for Victims Treated at Hospitals, Medical Facilities, or by a Medical Professional Solely on an Out-Patient Basis
- Category D – Nonprofit Organizations Serving Community Members not Physically Injured (these distributions were determined by the Highland Park Community Foundation)

Final approval of our distribution recommendations rested with the Committee.

There were numerous inquiries about the Fund and its protocol that we addressed. The Fund ultimately received 78 claims. A number of the claims were incomplete in one respect or another. We worked with claimants to secure the necessary documentation such as an appropriate medical letter. In 11 cases, claimants were not able to secure the appropriate medical letter. We therefore deemed those claims ineligible. One eligible claimant withdrew their claim. Ultimately, we received 66 eligible claims.

We offered to meet with claimants who were physically injured. Five claimants who were physically injured asked to meet with us. We met in person with each of them. We communicated with many other claimants by phone, text and email. In some cases, a claimant did not have a bank account in his or her name. We made referrals in those cases to local community banks that offered to be of assistance.

Once we had met with claimants and assisted a number of claimants in completing their claims, we began the work of determining the number of eligible claims in each category and the amount that would be awarded to each victim.

In doing so, we were sensitive to the impact a gift might have on government benefits to which claimants might be entitled. We encouraged claimants to consult with lawyers and accountants with respect to this issue, and the North Suburban Legal Aid Clinic made *pro bono* counsel available to those who could not afford counsel.

In making our final determinations, we considered, but were unable to make adjustments based on claimants' needs for ongoing home health care. We felt the number of nights spent in the hospital was the clearest reflection of the severity of the injury suffered and the only way to develop an equitable formula for distributions. We determined that any victim who spent at least 15 nights in the hospital suffered a "catastrophic physical injury." In addition, we determined that one claimant who had been in the hospital less than 15 nights suffered a life altering injury, and we treated that claim as catastrophic. With respect to each of the catastrophic injury claims, we consulted with the Committee to ensure the Committee was comfortable with our recommendation.

The final claim amounts were structured so that no one in Category B received more than Category A claimants. We also felt that anyone who spent a night in the hospital (Category B) should receive significantly more than individuals who were treated on an out-patient basis.

Final Recommendation

Our final recommendations were as follows:

- Each claimant in Category A receive \$365,000
- Each claimant in Category B receive \$36,000 for each night spent in the hospital
- Each claimant in Category C receive \$19,066

The recommended gifts were therefore as follows:

Category C	47 individuals	\$19,066	\$896,102

For claims made on behalf of injured minors, we required that each parent consent to the gift and to the gift recipient. We were clear that all gifts were intended for the benefit of the injured minor.

In the case of deceased adults with minor children, all parties agreed that the gifts were to be for the benefit of the surviving child.

Committee Approval

The Committee approved our recommendations on October 22, 2022. On October 23, 2022, we notified, in English and Spanish, all claimants whose claims were ineligible. On October 31, 2022, we notified (again in English and Spanish), each eligible claimant of the amount they were awarded. In some cases, claimants asked that their checks be mailed. In other cases, claimants elected to pick up their checks at Highland Park City Hall.

We are grateful for the generosity of donors to the July 4th shooting Fund that allowed us to support those who suffered physical injuries that, while never able to fully compensate victims for their suffering, might help them deal with the impact of this tragic event. It was an honor and privilege to serve in this capacity.

HPCF Nonprofit Distribution Committee

The Committee established a sub-committee to determine the best way to distribute funding to organizations that were addressing victims' mental health and other needs. David Reich was appointed Chair of the Nonprofit Distribution Committee (Grants Committee) by Betsy Brint. The Grants Committee was made up of nine members of the Highland Park Community Foundation, all of whom were active in the community, had vast grantmaking experience from their involvement with the Foundation, and were knowledgeable about the organizations that served the community. Four were Fund Committee members and possessed a clear understanding of the Committee's goals. Members of the Grants Committee who were HPCF Board Members had served as Directors of the Foundation for at least five years. The Committee also included the Foundation's Executive Director.

Nonprofit Distribution Committee Policies

The Grants Committee was charged with the distribution of funds to Category "D," as outlined in the Final Protocol.

The policies and procedures followed by the Grants Committee were established by the Fund Committee with input from members of the Grants Committee, community members, and other stakeholders. The Grants Committee's directive was to address the non-physical injuries victims and community members sustained as a result of the shooting.

Informing the Organizations

The HPCF maintains an extensive database of organizations that serve the community and, in the days and weeks following the shooting, communicated with them about the July 4 Fund as well as resources and other means of support for victims and community members.

As a result of publicity from the shooting, both generally and through the media (social and traditional), many organizations became aware of the Committee's activities and desire to support their efforts with grant funding. A notification regarding the potential to obtain grant funding was sent to all the organizations the HPCF had worked with in the past. The City of Highland Park and many of its partners also shared application information.

Applications

On August 14, 2022, claim forms for grants were emailed to all known organizations and also made available on the 4th of July Fund website. So as not to burden the organizations with unnecessary paperwork, the form was very straightforward and easy to complete. It required a brief description of the organization's mission and impact, the increased demand for services as a result of the shooting, and the population to be served. It also required an itemization of the costs incurred or to be incurred, the organization's most recent tax return (Form 990), and proof of exempt status. Sample forms in English and Spanish are included beginning on page 44.

The claim forms were to be completed and returned to the Grants Committee by September 14, 2022. Ultimately, 19 organizations submitted claim forms to the Grants Committee, seeking a combined total of approximately \$750,000 in funding.

Considerations for Funding

The Grants Committee carefully reviewed each claim with the following factors in mind: (i) whether the funding request was to address needs of victims related to the July 4th shooting; (ii) whether the organization provided a clear plan about how it would deliver its program or services to victims; (iii) who the organization ordinarily served; (iv) the needs generally addressed by the organization; (v) whether the intended results were well-defined and measurable; (vi) the expected impact of the grant; (viii) whether the organization had demonstrated a commitment to the community; (ix) the financial health and stability of the organization; (x) whether the organization was experienced in the type of work proposed; (xi) the availability of other funding; and (xii) any special circumstances. The request also had to be for expenses that were not reimbursable by any state or federal government.

Review of Applications

Each member of the Grants Committee was appointed as a liaison to two of the organizations. They spoke to or met with their organizations to gain additional insight into their programs and services. Liaisons followed up with their organizations both before and after the Grants Committee met to obtain additional information.

Committee Meeting

The Committee met to discuss their findings and review applications on October 12, 2022. Claim forms were carefully evaluated and discussed. The Committee members presented their findings about the organizations for which they served as a liaison and made funding recommendations. Final funding decisions were made by a consensus of the Committee.

Funding

Grants, totaling \$580,025, were provided for 17 organizations. Individual award amounts ranged from \$2,500 to \$100,000.

The grants went primarily to address mental health needs. Funds were also distributed to organizations that provided legal and other support services for victims and impacted community members,

Notification and Check Delivery

The Committee notified the organizations about their awards on October 21, 2022, and sent checks and letters to the organizations on October 31, 2022. As a condition of receiving assistance from the Fund, community organizations agreed to report on their use of the funds by December 31, 2022.
