



BIENVENIDO

Good afternoon [evening]. As Chair of the Highland Park Community Foundation, a local nonprofit agency with deep roots and a long history of helping our community, I extend my condolences and sorrow for your loss and injuries – for the circumstances that have brought us here today. I want to thank each of you for being here, and to acknowledge how difficult this must be. We cannot imagine your personal pain or loss, and we hope that we can make this phase of the process as straightforward and simple as possible for you and your families.

We knew our community would want to help in every way possible after the horrific tragedy on July 4th. That is why we created a Fund where people could donate gifts to provide compassion to victims and their families.

The Fund the Highland Park Community Foundation created provides a charitable vehicle for donors to provide that support as well as support for local nonprofit organizations serving the needs of impacted members of the Highland Park-Highwood community and other local communities.

When we started the Fund, from the get-go, we committed to using best practices and have sought the assistance of nationally recognized experts in the administration of similar victim funds, local community and nonprofit leaders. Their expertise and guidance have helped us move forward in a thoughtful, inclusive, and transparent way.

In July, the Foundation put together a committee to develop a process for the distribution of funds. The committee, *Together Highland Park Unidos*, is made up of local community leaders who are committed to an open, transparent, and expedient process to distribute the money donated to the Fund .

The Committee has committed to donating 100% of the funds received. None of the donations will be used for administrative or similar expenses.

Today is an important step in that process – we are meeting with you – the families and victims of this tragedy to discuss our proposed distribution process and to receive and listen to your feedback before we write the Final Protocol.

I want to start with an overview of our Committee's main goals:

1. To follow best practices and distribute the donations we are receiving as quickly as possible to the victims of the July 4th shooting and their families as well as nonprofit organizations that are helping victims, their families, and the broader community as a result of the shooting.
2. To provide transparency around the process for all stakeholders.

I want to offer an overview of the process we are undertaking to distribute the funds we collect.

The Highland Park Community Foundation is a trusted, local resource for the community. Established 30 years ago, the Foundation has extensive experience distributing grant funding and is also very familiar with the services provided by a wide network of nonprofits within our community.

The Foundation established the Fund immediately following the shooting. With its announcement, the City of Highland Park urged all those wishing to show their financial support to send donations to the Foundation.

The Foundation then reached out to nationally recognized experts – who have done this before – to learn as much as possible about the next steps.

The first thing to do was to form a committee that would propose a Protocol for the distribution of funds. It was important for the committee to include a variety of community leaders who would develop and follow an inclusive, sensitive, and transparent process.

The Committee was formed and on July 27th published a Draft Protocol, in English and Spanish. That began the listening period we are currently in to seek feedback from survivors, victims, and community members at large. We are meeting today



and tomorrow [today and we met yesterday] with victims and their families and have invited written comments from the public about the Draft Protocol.

The Final Protocol, which will govern how the funds are distributed, will take into consideration all the feedback we receive.

When the Final Protocol is published, which we expect will be on August 17th, claim applications will be available and we will announce the names of the Fund Administrators. Based on this timetable, claims will be due by 5 PM on September 7th.

Once the application period closes, the Fund Administrators will do their work to evaluate and process claims. Victims or their families may meet with the Fund Administrators to discuss their claims if they want to do so.

## CATEGORÍAS DE RECLAMACIONES

We know this is difficult to hear, but we want to share the proposed categories of eligible claims and share how we propose to process them.

We anticipate distributing money for four categories of claims.

### **A. Death Claims and Permanent Catastrophic Physical Injury Claims**

This category will include claims for deceased victims and those who suffered permanent catastrophic physical injuries as a result of the Parade shooting. Permanent catastrophic physical injury, such as paralysis, will be determined by the Administrators.

### **B. Physical Injury Claims for Victims Requiring Overnight Hospitalization**

We are proposing a category of claims for people who were physically injured and hospitalized within 7 days of the shooting (July 4th–11th) for one or more nights due to physical injuries resulting from the shooting. At this time, the payment is expected to be based on the number of days of continuous hospitalization. A signed letter from the applicable hospital will be required.

### **C. Physical Injury Claims for Victims Treated at Hospitals, Medical Facilities, or by a Medical Professional on an Out-Patient Basis**

Eligible claims in this category would be for individuals who were physically injured and treated as an out-patient within 7 days of the shooting (July 4th–11th) at a hospital or medical facility, or treated by a medical professional, and released

without an inpatient hospital stay. It is anticipated that eligible claimants in this tier will all receive the same payment regardless of injury. A signed letter from the applicable hospital, medical facility, or medical professional will be required.

**D. NonProfit Organizations Supporting Community Members not Physically Injured**

The Committee recognizes that the Parade shooting has resulted in injury to community members besides physical harm, creating a need for services beyond those customarily provided in scope or patient numbers historically. Since our funds are limited, it would be difficult to meaningfully address these sorts of individual claims. The Committee is therefore proposing to support Highland Park, Highwood, and other local nonprofit organizations serving these needs.

I want to stress that these are proposed categories. Based on your input and community feedback, they could change with the publication of the Final Protocol.

Next we will review our proposed process and procedures for processing claims.

The process, from a victim's or family's standpoint, begins by submitting a claim form. Forms will be available when we publish the Final Protocol, which we expect to do on August 17. Both the Final Protocol and Claim Forms will be available for download at [July4Fund.org](http://July4Fund.org) and hard copies will be available at the Highland Park and Highwood public libraries. Copies may also be requested by emailing [info@July4Fund.org](mailto:info@July4Fund.org) or by calling (773) 733-0650.

Local official agencies and other involved agencies will assist, to the best of their abilities, in notifying eligible claimants about them. The claim forms will be published in English and Spanish, straightforward and simple to complete, and due on or before September 7th. We will help people complete them if needed.

If an eligible claimant fails to submit a Claim Form by the due date or otherwise elects not to submit a Form, the funds that would otherwise have been paid to such claimant will be available for distribution to the eligible claimants submitting Claim Forms.

The Committee develops the Protocol – but does not make decisions about distributing funds. We will appoint independent Administrators, acting jointly, to administer the Fund. The Administrators will be given the authority to apply the Final Protocol and provide all relevant interpretations for the distribution of

financial assistance to claimants. The Administrators may seek input and determinations from the Committee and will schedule individual meetings with claimants to answer questions and clarify application information, if needed.

We will only be accepting one claim and issuing one payment per victim.

All Claim Forms must be complete before they are submitted. In the event a claimant submits an incomplete or deficient Form (for example, fails to include required documentation or sign the Form), a representative of the Committee will try to assist, but Forms must be complete in order to be considered.

Payments will be issued by check and sent to claimants via certified mail or as otherwise specified by the claimant on the Claim Form.

- Una reclamación para víctimas fallecidas debe ser presentada por el representante personal de la sucesión

- A Claim for a deceased victim must be submitted by the personal representative of the estate
- A Claim for a minor child or other person subject to legal guardianship must be submitted by the individual's legal guardian

Las reclamaciones por lesiones físicas que requieran hospitalización durante la noche deben incluir una carta firmada del centro médico que confirme:

- Fecha de admisión
- Fecha del alta hospitalaria
- Que la lesión fue sufrida como resultado del tiroteo en el desfile del 4 de julio

A Claim Form filed for a physical injury claimant who required overnight hospitalization must include a signed hospital or medical facility statement on official letterhead from the hospital or medical facility that confirms:

1. the date of admission to the hospital or medical facility;
2. the date of discharge from the hospital or medical facility; and
3. that the injury was sustained as a result of the Highland Park 4th of July Parade shooting.



## PROCESOS Y PROCEDIMIENTOS



Las reclamaciones por lesiones físicas tratadas fuera de un hospital o centro médico deben incluir una carta firmada de un profesional médico que confirme:

- Nombre e información de contacto del profesional médico
- Fecha del tratamiento
- Que la lesión fue sufrida como resultado del tiroteo en el desfile del 4 de julio

If a physical injury claimant was treated by a medical professional outside of a hospital or medical facility setting, the Claim Form must include a signed letter from the professional that confirms:

1. the medical professional's name and contact information;
2. the date of treatment; and
3. that the injury was sustained as a result of the Highland Park 4th of July Parade shooting. The Administrators may require additional support, such as an affidavit.

Following submission of a Claim Form, optional meetings will be scheduled at the claimants' or Administrators' request. These meetings will be scheduled in-person, by phone, or by videoconference before the Administrators make their final payment determinations, but will not alter the terms and conditions of this Protocol. Requests to meet should be sent by email to [info@July4Fund.org](mailto:info@July4Fund.org) or by calling (773) 733-0650. We expect to provide translation services upon request.

## PROCESOS Y PROCEDIMIENTOS



- No puede proporcionar asesoramiento fiscal y legal
- Se realizará una revisión independiente y se publicarán los resultados
- Todas las reclamaciones son confidenciales

Neither the Fund Committee nor the Administrators can provide legal or tax advice to those receiving payments from the Fund. We recommend claimants consult with an attorney or tax advisor for any legal questions or questions regarding tax liability for these payments. No person has a legal claim or entitlement to receive payment from the Fund.

A full independent review of the Fund will be conducted by an independent auditor as soon as possible after all eligible claims have been paid and grants have been issued to Nonprofit Organizations. The results of this review will be made available to all claimants, donors, and the general public, along with a Final Narrative Report from the Administrators.

All claims are confidential and we will not publish the names of the claimants or the amount of individual awards.
